In the last years, the eurozone got confronted with different severe crisis: the Great Recession (Global Financial Crisis) and the Euro crisis (debt and banking crisis). Additionally, other challenges might affect, in the future, the eurozone economies through international economic transmission channels: the Middle East conflict with high implications on oil price or the Chinese economic rebound.

Within this framework, a specific attention can be devoted to the interaction between globalization and economic growth with a specific focus on the EMU.

Submission of Papers

Only full papers may be submitted for presentation at LE STUDIUM Conference. Papers must be in English and must include a cover page with the following information:

- Paper title and an abstract of up to 500 words, with JEL classification and no more than 5 keywords;
- Authors' full name and affiliation;
- Contact details for the corresponding author, such as address, phone and e-mail.

Deadline for paper submission is: May 31, 2017

All submitted papers will be peer reviewed according to a high-quality and fast referee process. Authors will be notified whether their paper is accepted for **oral presentation or poster session** at the conference not later than **June 30, 2017**.

Orléans is a city in north-central France, located on the Loire River, about 130 kilometres southwest of Paris. It is the capital of the Centre region and belongs to the Loire Valley which was added by UNESCO to its list of World Heritage Sites. Orléans is one hour away from Paris - Austerlitz station by train (SNCF website: www.voyages-sncf.com). There are two train stations in Orléans: "Les Aubrais" and "Orléans Centre". If you arrive at "Les Aubrais", take the tram line A (direction Hôpital La Source) and get off the tram at "Gare d'Orléans" station. From "Orléans Centre" train station or "Gare d'Orléans" tram station, Hôtel Dupanloup is at 15 minutes walking distance.
