Submission of Papers

Only full papers may be submitted, in pdf or rtf-format. No other format will be accepted. **Papers should be submitted** electronically to:

infer@cefimo.ro

Extended Deadline for paper submission is May 19, 2013.

We accept only one paper submitted by the same author. We will confirm receipt of your submission.

Papers must be in English and should not exceed 25 pages (A4 or letter) including all references, tables and the like. The text should be formatted in Times New Roman 12pt with 18pt line space and 2.5 cm (1 inch) margin on each side. Footnotes should be formatted in 10pt with 10pt line space. Please avoid colours in graphs and pages in landscape.

All papers must include a cover page with the following information:

- An abstract of up to 500 words, with JEL classification and no more than 5 key words;
- Authors' full name, affiliation;
- Contact details for corresponding author, such as address, phone and e-mail.

All submitted papers will be peer reviewed according to a high-quality and fast referee process. You will receive an e-mail indicating whether your paper is accepted for presentation during the workshop or not before **May 31, 2013**.

Paper presenters are expected to discuss one other paper during the workshop. The discussant assignments will be made by the workshop organizers at a later date. As the workshop intends to build a network in this research area, participation is welcome even without paper contributions.

Publication of Papers

A selection of papers presented at the workshop will be published in one or more international publications. *INFER* offers several publication possibilities to workshop participants, including book volumes and journal publications. Moreover papers of excellent quality may be published in a special issue of good international journals. The workshop organizers will contact you about these publication possibilities later.

Registration and Registration Fee

The registration fee for presenting and non-presenting participants will be:

- 80 EUR: *INFER* members
- 120 EUR: other participants

Please note: the annual membership fee for private *INFER* members is 25 EUR only (institutional *INFER* members 200 EUR). You are invited to become a member!

Please note that paper submission is not regarded as a registration. A registration form will be sent to the authors of the accepted papers.

Location and Travelling

Bucharest is the capital municipality, cultural, industrial, and financial centre of Romania. It is the largest city in Romania and lies on the banks of the Dâmbovița River. Bucharest was first mentioned in documents in 1459. It became the capital of Romania in 1862 and is the centre of Romanian media, culture and art. Its architecture is a mix of historical (neo-classical), interbellum (Bauhaus and Art Deco), Communist-era and modern. In the period between the two World Wars, the city's elegant architecture and the sophistication of its elite earned Bucharest the nickname of "Little Paris". In recent years, the city has been experiencing an economic and cultural boom. Economically, Bucharest is the most prosperous city in Romania and is one of the main industrial centres and transportation hubs of Eastern Europe.

Most international flights arrive at **Henri Coanda International Airport** (*Otopeni*), located about 12 miles north of downtown Bucharest. Major car rental companies have offices located on the baggage claim level.

Several taxi companies operate in Bucharest, and their rates can vary. Taxis can be hailed in front of the arrivals terminal. There are no flat rates for transfers from and to Bucharest Airport to downtown. Rate / km is 3.50 lei (about \$1.00) and a trip to downtown Bucharest should cost no more than the equivalent of \$25.00. Make sure to confirm the rate before you leave the airport.

Express Bus 783 offers daily service to the city centre, with stops at **Baneasa Airport**, *Piata Presei Libere*, *Piata Victoriei*, *Piata Romana*, *Piata Universitatii* and *Piata Unirii*. The bus leaves from the international departures terminal every 15 minutes (every 30 minutes after 8:30pm and during weekends), from 5:30am until 11:00pm. The journey to downtown takes approximately 40 minutes. Fare is 7 Lei (about \$2.5) for a round-trip ticket.

Express Bus 780 offers daily service to the main train station (*Gara de Nord*) with stops at: **Henri Coanda Airport** - Baneasa Airport - Piata Presei Libere - Clabucet - **Gara de Nord** - Str. Fluviului. The bus runs every 30 minutes from 5:15 a.m. to 11:00 p.m. seven days a

week. It leaves from the international arrivals terminal; the journey to the train station takes 40 minutes to 60 minutes. A roundtrip ticket costs (about \$2.50) per trip. *Note:* You need to purchase a *RATB* ticket before boarding the bus (for sale at the '*RATB*' ticket booth in the arrivals terminal; Open: Mon - Sun. 6:00 a.m. - 8:30 p.m.

Henri Coanda Express Trains offer daily service from Balotesti (0.5 miles from the airport) to the main train station (*Gara de Nord*) with one stop at Mogosoaia. Trains run hourly from 5:56 a.m. to 9:00 p.m.; the journey from the airport to the train station takes about one hour and 10 minutes. One-way ticket costs 6 Lei (\$2.20). Transfer from Balotesti train station to the International Arrivals Terminal is included. Tickets can be purchased at the CFR booth International Arrivals Terminal.
