Workshop Objectives

This workshop provides an opportunity for all those interested in the **Economics of European Integration** to discuss new research and to exchange ideas. Researchers are invited to submit both empirical and theoretical papers broadly consistent with this workshop's special topic: **Recent Issues in European Economic Integration and EU Enlargement.**

The workshop is open to anybody involved in international and European issues, including both young and experienced researchers, Ph.D. students, post-doctoral researchers, and professionals from business, government and non-governmental institutions.

Although all papers in this field may be submitted, in particular empirical and theoretical research regarding the following topics is welcome:

- Economic evaluation of the future enlargement of the European Union (Western Balkan countries, Turkey, Ukraine, Iceland, etc.)
- Economic evaluation of previous EU enlargements (e.g., Central and Eastern European Countries, Malta, Cyprus)
- Evaluation of Eurozone enlargements

- Topical studies on international trade, FDI, economic geography, labour, monetary aspects in a European context etc.
- New insights into European policy after the financial crisis

Location

The workshop takes place at the city campus of the HUB (University College Brussels or H.U.Brussel), situated in the historical centre of Brussels and close to the European Union institutions.

Submission of Papers

Only full papers may be submitted, preferably in pdf-format. Papers should be submitted by sending an e-mail to Jan Van Hove (jan.vanhove@econ.kuleuven.be).

Deadline for paper submission is April 1, 2011.

Authors are allowed to submit more than one paper. All submitted papers will be peer reviewed according to a **high-quality and fast referee process**. Authors will be notified before April 15, 2011 whether their paper is accepted for presentation during the workshop.

Paper presenters are expected to discuss one other paper during the workshop. The discussant assignments will be made by the workshop organizers at a later date. As the workshop intends to build a network in this research area, participation is welcome even without paper contributions.
