How to get from the Airport to ISEG

Lisbon's main airport is Lisbon Portela Airport in Lisbon, 10 kilometres from the conference venue at ISEG/Technical University of Lisbon.

Taxis are the easiest way to get into town and are available outside the Lisbon Portela Airport. The journey to city centre takes about 20 minutes. All of the taxis are beige and have digital meters and must run them. The cost of getting from the airport to the (city centre) is about 15 euros daytime. Most taxis do not accept credit cards. It is not necessary to tip taxi drivers.

You can also take the metro to Cais do Sodré or Rato and then take a bus (Number 706 or 727) to Av. D. Carlos I, just in front of ISEG.
