Submission of Papers

Full papers or extended abstracts may be submitted, preferably in pdf-format, by sending an e-mail to Huw Edwards (T.H.Edwards@lboro.ac.uk).

Submission Deadline: December 1, 2013.

Authors are allowed to submit more than one paper. All submitted papers will be peer reviewed according to a high-quality and fast referee process. By mid-December 2013 authors will be notified whether their paper is accepted for presentation at the workshop.

Paper presenters are expected to discuss one other paper during the workshop. The discussant assignments will be made by the workshop organizers at a later date. As the workshop intends to build a network in this research area, participation is welcome even without paper contribution.

Registration and Registration Fee

All participants have to register for the workshop. A registration fee has to be paid. Please note that paper submission is not regarded as a registration. After your registration, you will receive a confirmation e-mail.

Location and Travelling

The workshop takes place at the School of Business and Economics in Loughborough. Loughborough is at the heart of England in the northern most part of the county of Leicestershire and being centrally placed it is well served by road, rail and air.

Main line road and rail networks link Loughborough directly with the rest of the country and the town itself is served by excellent bus services.

Loughborough University is less than two miles away from junction 23 of the M1 motorway.

London is one-and-a-half hours away by train, Birmingham one hour and Manchester and Leeds around two hours.

There are regular scheduled flights from UK, European and international destinations to East Midlands Airport, only 7 miles away.
