## Call for Papers TIMTED 2023

The 7th edition TIMTED 2023 (June 8-9, 2023) aims to bring together academics, researchers, Ph.D. students, as well as professionals from around the world.

### ACCEPTED PAPERS

The authors may send full papers or extended abstracts. These will be first evaluated by the Conference reviewers. Extended abstracts of 1600 to 2200 words will have the same structure as full papers: introduction, literature review, methodology, results and conclusions. A maximum of two papers may be submitted to the conference by every participant, as sole author or co-author. Only original papers are accepted, on subjects related to all fields of economics and business administration.

The conference aims to provide participants with a high-quality scientific context and to facilitate debates and the exchange of ideas and opinions on contemporary social problems: globalization, the capricious and dynamic organizational environment, the development of digital technologies etc.

The conference encourages interdisciplinary research grounded in economics and business but related to other fields such as political science, digital technologies etc.
